SECTION 5: Fire-fighting measures

Extinguishing media:

Suitable: NFPA Class III B (Combustible liquid): Use water spray, ABC dry chemical, foam or carbon dioxide. Water or foam may cause frothing. Use water to keep fire-exposed containers cool. Water spray may be used to flush spills away from exposures.

Special hazards arising From the chemical:

Unusual fire/explosion hazards: Product is not considered a fire hazard, but will burn if ignited. Closed container may rupture (due to build up in pressure) when exposed to extreme heat.

Precautions for safe handling: As with any chemical product, use good laboratory/workplace procedures. Do not cut, puncture, or
